

## SEC Proposes Major Changes to Executive Compensation Disclosure Requirements

On January 17, 2006, the SEC voted to approve proposals that would amend disclosure requirements for executive and director compensation, related party transactions, director independence and other corporate governance matters, and security ownership of officers and directors. The proposals would affect disclosure in proxy statements, annual reports and registration statements and modify the current reporting requirements of Form 8-K regarding compensation arrangements. The proposals would also require most disclosures to be written in plain English.
