This Calendar covers certain (but not all) regulatory obligations of a typical U.S.-based private fund adviser. This Calendar does not address all potential regulatory reporting and compliance obligations applicable to a private fund adviser, including, but not limited to, those arising under: (i) state reporting regimes; (ii) the Commodities Futures Trading Commission (“CFTC”) or the National Futures Association requirements (other than the annual affirmation requirement applicable to commodity pool operators exempt or excluded from registration under CFTC Rule 4.5, 4.13(a)(1), 4.13(a)(2), 4.13(a)(3), or 4.13(a)(5) or commodity trading advisors exempt from registration under Rule 4.14(a)(8)); (iii) rules or regulations of the Financial Industry Regulatory Authority, Inc. (other than annual “new issues” certifications); (iv) tax; (v) ERISA; and (vi) non-U.S. regulatory regimes.

Annual Amendment to <a href="#">Form D</a> .	Securities Act <a href="#">Rule 503(a)</a> requires an issuer that has sold securities in an offering based on a claim of exemption from registration under Rule 506 of Regulation D to file a notice of an exempt offering of securities on <a href="#">Form D</a> with the SEC. Notice must be filed within 15 days after the first sale of securities in the offering. A previously filed Form D must be amended: (i) annually, on or before the first anniversary of the most recent previously filed notice, if the offering is continuing at that time; (ii) to correct a material mistake of fact or error in the previously filed notice, as soon as practicable after discovery of the mistake or error; and (iii) to reflect a change in the information provided in the previously filed notice, except in limited circumstances, as soon as practicable after the change.
