He subsequently was appointed head of the legal affairs unit and head of the unit for single market policy in the Directorate-General for Internal Market and Services. In 2015, he moved to the Directorate-General for Competition, serving as head of the unit and Acting Director for Transport, Post and Other Services. Morch began his career in private practice.
